GreenLine Systems To Participate In Operation Safe Commerce

GreenLine, Unisys to Collaborate on Supply Chain Security Technology

SAN FRANCISCO, CA, Calif./EWorldWire/July 22, 2003 --- GreenLine Systems Inc., will supply risk management software as part of the Unisys Corporation (NYSE: UIS) safe commerce solution selected by the Port Authority of New York and New Jersey under Operation Safe Commerce (OSC). GreenLine Systems has developed a software solution to help companies monitor their risk and security profile associated with facilities, assets and containerized shipments in global trade.

"We believe that Operation Safe Commerce validates our vision of Trusted Trading Partner Networks™ that satisfy emerging government standards for safe and secure cargo. Introducing collaborative risk management capabilities will provide our customers with the benefit of additional supply chain efficiencies," said Noah Rosenkrantz, CEO of GreenLine Systems. "Our strategic partnership with Unisys was a critical key to this success and we are delighted to be able to contribute to a project that is so important and crucial to our national security."

OSC is a federally funded Transportation Security Administration (TSA) project that will pilot a combination of processes and technologies to help secure companies' global supply chains and cargo—while at the same time facilitating cross-border movement of legitimate commerce. The grants will help identify existing vulnerabilities in the supply chain and develop improved methods for ensuring the security of cargo entering and leaving the United States.

In this funding phase, Operation Safe Commerce is concentrating on three major load centers – the ports of Seattle and Tacoma, Los Angeles and Long Beach, and the Port Authority of New York and New Jersey. The pilot solution will involve a Brazil-New York trade lane in conjunction with Sara Lee Coffee & Tea Foodservice and Atlantic (USA), Inc.

Unisys will integrate the GreenLine Systems risk management software into its Safe Commerce Solution for the Port Authority of New York and New Jersey. GreenLine's solution aggregates risk-related data about facilities and shipments, screening the information for anomalous events and behavior. It enables users to identify potential security threats to facilities and shipments and notify key personnel or first responders of their existence. At the same time, it permits users to identify and expedite those shipments that are deemed safe and secure, while allowing Customs and law enforcement to focus on shipments with a suspect or unknown handling history.

"GreenLine aligns well with our vision to develop an integrated framework to solve Safe Commerce challenges--one that allows real-time evaluation of activities across the supply chain, protecting assets and preserving customer relationships," said David Jordan, president of Unisys Global Commercial Sector. "While the prevailing wisdom suggests that it might take four to five years to build a comprehensive security system around U.S. seaports, risk demands that we move faster. The technology is available today and the Unisys-GreenLine team has the experience to move quickly and effectively on this project."
